SUBJECT: APPROVAL TO USE THE ANNUAL TRAINING ALLOTMENT FOR THE ASSOCIATION OF PUBLIC-SAFETY COMMUNICATIONS OFFICIALS WESTERN REGIONAL CONFERENCE

The Northern California Association of Public-Safety Communications Officials (APCO) are hosting the APCO Western Regional Conference in Sacramento at the Sacramento Convention Center, April 7 – 10, 2015. The California 9-1-1 Emergency Communications Branch (CA 9-1-1 Branch) approves the 9-1-1 County Coordinator's and Public Safety Answering Point's (PSAP's) use of their Annual Training Allotment (ATA) of \$3,000 for state Fiscal Year (FY) 2014-2015 to attend the CALNENA Training/Meeting. The 9-1-1 County Coordinators and PSAPs are responsible for monitoring and tracking their ATA. Training reimbursement cannot exceed \$3,000 for FY 2014-15.

The attached State of California Travel Reimbursement Rates reference document provides information regarding the State's reimbursement rates for FY 2014-2015. The second page of the reference document reflects the ATA eligible lodging reimbursements that include the APCO Western Regional Conference hotel location's negotiated rate and state lodging reimbursement rate for Sacramento County.
